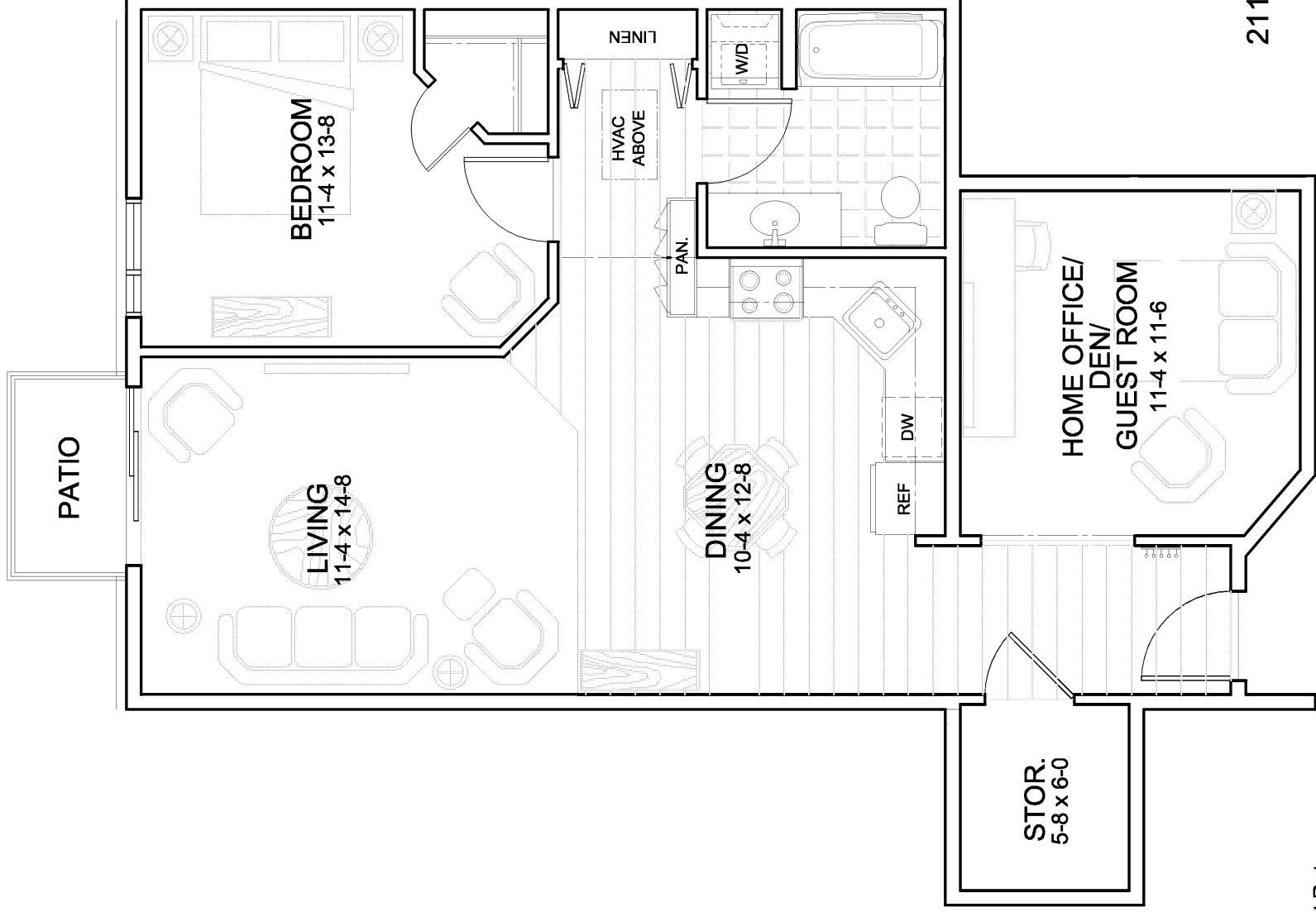


UNIT KEY PLAN

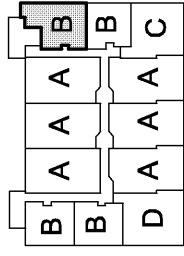

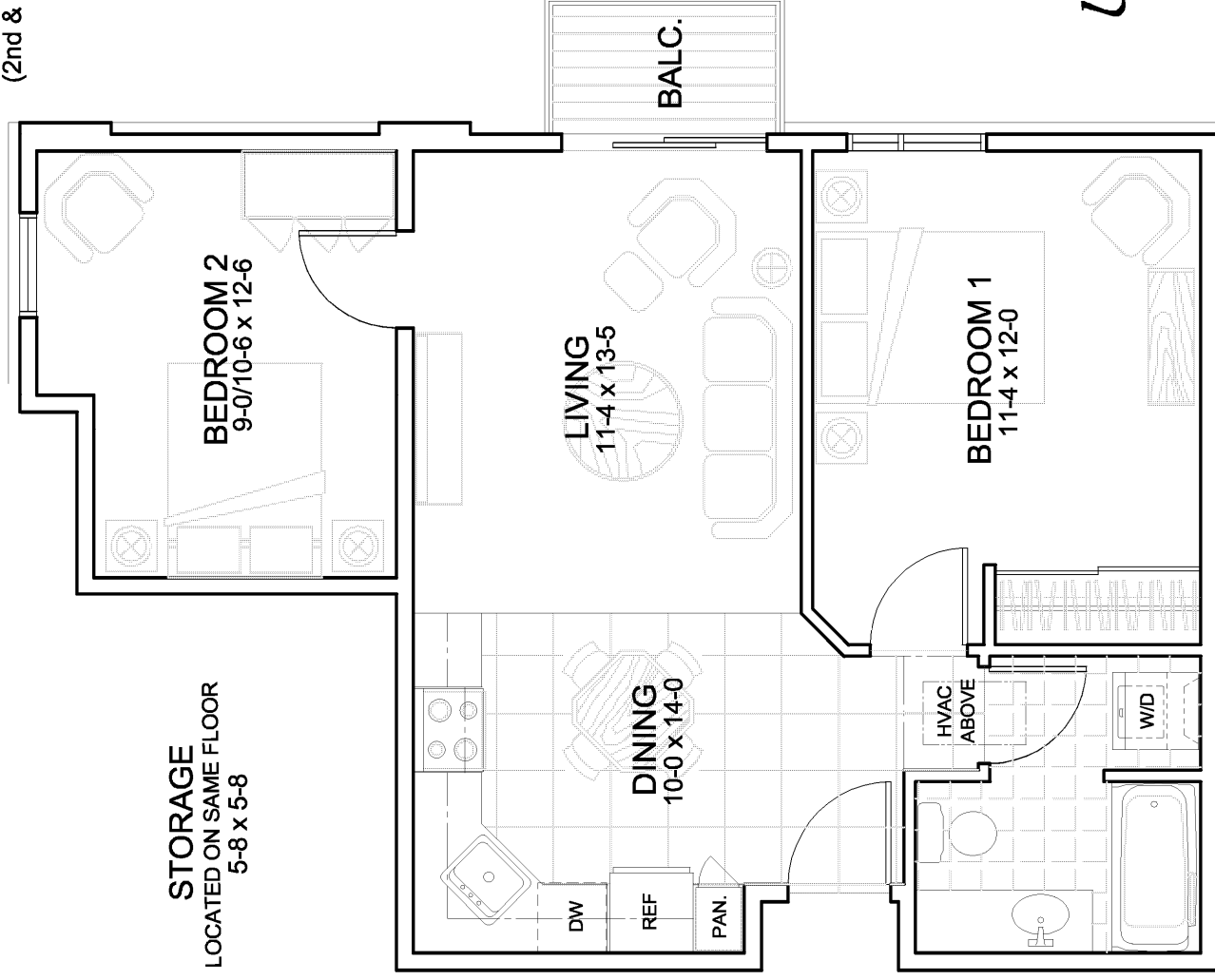
